

# Conference Report ERA & UKKW

## ERA 2024

Stockholm

Late Breaking clinical Trials

#### The FLOW study:

- Semaglutide in T2DM
  - eGFR 25-75 on RAASi 12% of patients eGFR<30</p>
- Double blind, randomised, placebo controlled, worldwide
- Primary outcome was major kidney disease events
  - these were 24% lower in treatment arm
- Reduction in eGFR slope of 1.16ml/yr
- HR 0.79 for renal outcome, HR 0.71 for all cardiovascular causes
- Also REWIND = dulaglutide = reduction of 25% of renal outcomes

#### •ALIGN – early results Phase 3 trial


- Atrasentan in IgAN endothelin A receptor antagonist in addition to ACEi/ARB
- Reduction in proteinuria of 36% vs placebo



## ERA 2024

Key messages coming out

- ■IgAN lots of new therapies being trialled
  - Turn off IgA production (budesonide) AND reduce glomerular inflammation (BAFF / APRIL or complement) AND treat CKD – ACEi/ARB endothelin antagonists
  - Complement iptacopan / ravalizumab
  - BAFF / APRIL sibeprenlimab / atacicept / zigakibert
- NHSE doing some work on how these will be funded / fit into a pathway.....
- ■Treatment for CKD with T2DM 4 pillars
  - ACEi/ARB
  - SGLT2i
  - MRA
  - GLP-1



## **UKKW 2024**

#### •lgAN

- Again the new medications that are being trialled
- Message around stopping the disease progression and treating the CKD progression
- Changing the mind set to more like AAV stop disease progression

#### Lupus

 Use of voclosporin – high cost CNI – licensed and being used in some centres – discussion around whether tacrolimus is as good – but not proven in trial or licensed.

#### RPG talks

- Robert Roxadustat use across the UK already presented at a Q&A
- Denise uromune clinic and use of a vaccine

## **UKKW 2024**

#### •CKD

- Kidney networks at different places with CKD optimisation
- Lots of data sources out there but no one good source
- LUCID project Leicestershire
  - 1) education (using the Leicester videos for patients too)
  - 2) identification of patients (for LUCID clinics)
  - 3) Optimising (medicines)
  - 4) Surveillance (monitoring for progression of CKD)
  - With right person, Rupert emphasised a pharmacist colleague, from the PCN can now run LUCID clinic independently.
  - Funding going forwards
- Morgan Grams (New York/ KDIGO) keynote speaker
  - emphasised need to optimise CKD management
  - KFRE does not correct for risk of death
  - People at greatest risk of death have greatest benefit from therapy

# **Supply Problems**



- Sando K/slow Na/sando phos
  - Supplies appear resolved
- Taurolock U/Alteplase
  - Taurolock U back?
  - Alteplase 2mg still OOS options include ULM alteplase (cost pressure) or urokinase
- Mycophenolic acid 360mg
  - Generic issues ongoing, Sandoz are limiting supplies to instalments for homecare companies
- Ibandronate/Pamidronate
  - Unlicensed pamidronate being explored
  - Some centres looking into using zolendronic acid/denosumab depending in indication

## **Supply Problems**

- Ganciclovir
  - Vials in stock, some supplies of pre made bags
- 5% HAS
  - Units diluting higher strength HAS to achieve 5% concentration
- Finerenone not a supply issue but single wholesaler route presenting problems
- Budesonide not supply issue but issues getting accounts set up, now available through Phoenix.
  - ? How to manage acute illness ?need to double dose TBC
- Basiliximab transplant centres on monthly allocation, unlicensed supplies available but very £££
  - ? National UK stock coming in earlier. Problems with unlicensed stock coming in import ban with restricted stock. Units should escalate to national commissioners about cost pressures. Trusts being asked to utilise mutual aid

- Workforce planning documents currently BRS document from 2020 most up to date.
  UKKA summit looking at workforce in the autumn
- Renal pharmacist band 7 to band 8 terms of framework
- Sodium bicarbonate 1.4 %
- Primary care talks on CKD management
- Osteoporosis guidelines in CKD

## Q&A Themes - Renal



- Avacopan eligible patients
- Inadine (PVP-I) non-adherent dressings CI in kidney disease
- Roxadustat for very low body weight (max tolerated dose 3 mg/kg body weight)
- UKKA enquiry which trusts permit pharmacy technicians to liaise with clinicians regarding withholding/restarting medications of nephrotoxic potential
- Rituximab for glomerular diseases
- Tetrabenazine in eGFR 13 ml/min
- Prescribing restrictions in SGLT2 inhibitors warnings for DKA
- DDAVP for high risk biopsies
- Membranous/MCD regular Rituximab based on CD19 counts or wait for relapse
- Tolvaptan NICE criteria or ERA recommended age-index GFR model to identify rapidly progressing disease

# **Q&A Themes - Dialysis**



- Hydroxycobalamin IV on dialysis
- Riluzole on dialysis
- Dispensing of etelcalcetide for dialysis units
- Cabotegravir-Rilpivirine injections on HD
- Sodium cromoglicate in ESRD
- Amikacin doses on HD
- GLP1 agonists in HD patients to achieve weight reduction to get them on the list for transplant
- Rotigotine patches for restless legs in HD
- Hyperkalaemia with oral labetalol

## **Q&A Themes - Transplant**

- IP course in transplant
- Mannose prophylaxis against UTIs in transplant
- SGLT2 inhibitors in transplant patients
- Efudix 5 % cream in renal transplant patients
- Dose adjustment between Adoport and tacrolimus liquid
- Immunosuppression with kennel cough vaccine
- HRT in CKD/transplantation
- CMV how long for prophylaxis following two negative results
