Advisory boards

Discussions with a mentor on the setting up of appropriate advisory board(s) with respect to the treatment pathways, or QI (quality improvement) initiatives to address variation for relevant therapeutic areas, in diabetes or with additional new entities.

Rare Diseases

The value of this area is not for main stream drugs or services, but for those interested in orphan drugs used in renal medicine.

The value that the Renal Association can give to a company is not necessarily primarily in the post-marketing stages of a product life-cycle. However, the research capability that could be offered is potentially earlier than the completion of registration studies. This is where specialist audit and the data collection of the Registry could augment a clinical trial programme for safety and efficacy (for registration) and post-marketing surveillance.

There is also potential for improvement in the identification of people with rare diseases and their inclusion in the RaDar database.

eLearning packages

eLearning packages on the Moodle education platform on The Renal Association web-site could be developed collaboratively to assist in the training and engagement of clinical staff. They could be accessed by Renal Association members at no additional cost and sign-posted as part of the eBulletins in Renal Association newsletters.
